3.2 Practice

- Both fields will be used for the competition some days. On Friday morning, 19 May 2023, there will be free practice for people still involved in competition alongside VI Qualification. Practice will be run in rhythm with VI Qualification.
- A schedule for free practice will be published with time; fields will be open for people still involved in the competition.

3.3 Equipment inspection:

- During official practice of the related category.
- Located between the 2 fields of play.
- Teams will be announced in (English) alphabetical order by the DOS.
- All teams are to wear their team uniform and have their valid accreditation.
- Spare equipment must also be brought for inspection.
- Classification card must be presented during the inspection.
- Team managers must check the details of their athletes such as, name, date of birth are correct beforehand.
- Inform the Judge if details are not correct and the Judge will inform Results Team.
- Instructions to use the tablet scoring system will be carried out if requested.

3.4 Athlete / Assistant / Spotter (back) Numbers:

- Athlete numbers will be issued on the day of the qualification round (with the score cards) during practice.
- Athlete numbers must be worn on the quiver or thigh, facing the waiting line while shooting.
- Assistants and spotters (for VI) must wear the same back number as the athlete they assist to.

3.5 Qualification round

3.6 Individual elimination round

- Target faces will **NOT** be changed after practice arrows. Please instruct your athletes and assistants to mark all arrow holes during practice.
- Matches will start as soon as the field is ready.
- Matches at the start of each session will begin on time. Proceeding matches will follow up on the immediate completion of the prior match. Athletes should be alert and prepared for their matches to start slightly earlier than scheduled.
- In case of a bye, athletes may be allowed to shoot on their own target, provided the
 competition schedule allows. If the competition schedule allows, no score will be recorded
 or displayed and athletes shooting their bye must respect the DOS timing and signals of
 the competition. Recurve athletes are permitted to shoot 3 sets of practice and compound
 athletes are permitted to shoot 5 ends of practice for their bye.
- There will be no alternate shooting during the preliminary elimination rounds.





3.7 VI Category

- As there are insufficient final entries in either VI division, a single competition combining all VI athletes will proceed with all VI athletes wearing a blindfold regardless of their respective classification.
- The VI spotter <u>must now sit</u> 1m behind (WA Rules Book 3 21.12.9)

 A VI athlete is permitted to have a person acting as a spotter who must sit behind the athlete 1m behind the shooting line.
 - The role of the spotter is to tell the athlete the position of the arrows in the target face and also to inform them of any safety issues.
 - The spotter shall not disturb the other athletes while giving coaching assistance. During individual matches a VI athlete may have a spotter or a coach but not both
- The schedule has been updated to be shorter and to avoid too many days with no shooting for VI.

3.8 Doubles and mixed teams elimination/finals rounds

- The doubles event is run in the same way as the mixed team event
- During Eliminations both teams will shoot at the same time (WA Rules Book 3 13.2.2)
- Finals will run with Alternate Shooting (WA Rules Book 3 13.2.3)
- Wheelchair athletes may stay on the shooting line throughout the match. They indicate that they have finished shooting by raising a hand above the head

3.9 Appeal procedure (Form attached)

- An Appeal form is attached to this document (see attached after this chapter, Appendix 1).
- In case of an intent to appeal or an actual appeal, the times indicated on the Appeal form must be considered.
- Appeal forms should be given to the Chairman of the Tournament Judge Commission or to their deputy.
- A fee of US\$50- (Euro 50.-) must be paid to the Chairman of the Tournament Judge Commission, for the appeal to be valid.
- If the appeal is upheld by the Jury of Appeal, the fee will be returned. In the case of the appeal being rejected, the fee will not be returned.

4 Technical matters (TD + CoJ)

4.1 Missing arrows

• All missing arrows on the practice or qualification field must be reported to the Judges and Field Crew immediately.





4.2 Timing control system

ARCHERYCLOCK system will be used for timing on the main field.

4.3 Results system

- Qualification Round scoring will be completed by athletes or assistants. One athlete/assistant records, on the official paper-based score sheet, the scores of all other athletes on that target. At the same time, another athlete, on that same target, will enter all the scores of the athletes on that target into the scoring tablet. The other athletes should verify that all scores are written and entered correctly.
- Scorecards MUST be signed by both the athlete and the scorer, have all the totals
 mathematically correct with the 10s+Xs and X count fully completed. Any scorecards
 where the 10s+Xs and X count are not completed a "0" will be given for the total of 10s+Xs
 and X count for that athlete. Any score cards not signed or the score total is missing will
 result in disqualification.
- Elimination Round scoring will be completed by athletes/assistants. One athlete/team records the arrow values of both athletes/teams on the paper score sheet. While at the same time, the other athlete/team inputs the arrow values into the scoring tablet. Both athletes/teams should verify that all scores are written and entered correctly before returning back to the shooting line.
- At the end of the match, the scorecard must be fully completed and signed by the athletes (or agent/judge in the case of finals) involved in the match.
- Scoring tablets will be used during the Qualification and Elimination Rounds, but not in the Finals. Mr. Marco Carpignano is responsible for the results of the event.
- IMPORTANT NOTE: There will be internet access in hotels. Because of this we will not distribute any printed results and information.
 - Anyway there will be "Pigeon boxes" for teams at the venue to collect additional information. TM should check the mail boxes at least twice a day (morning/ afternoon).

5 Rules that apply in this event

5.1 The rankings

- The Para World Rankings (https://worldarchery.org/world-ranking) are updated every two weeks.
- European Para Archery Cup points will be allocated according to the PARA-ARCHERY EUROPEAN CUP CIRCUIT Rules V2.1 April 2022 published on the WAE website at <u>Documento1</u> (archeryeurope.org)





5.2 Dress regulations

- Athletes, officials and staff should wear the appropriate clothing having the correct appearance when on the field during competition. Open-toed shoes or camouflage clothing, accessories or archery equipment are not permitted.
- Athletes, team officials and technicians should wear their national team uniforms and sports shoes having the same appearance as per the division, following World Archery rules.
- During finals with TV coverage, undershirts, compression shirts or sleeves may be used on condition that they match the team uniform colours or are white. Under shirts and sleeve may include design, names or markings but the predominant colour should be white or the colour of the uniform.
- We would like to remind all teams that athlete names and country names or codes are mandatory on the back of their national team uniform shirts for athletes participating in World Archery major events.

5.3 Accreditation cards rules

Rule Book 2 – 3.8 Accreditation

- 3.8.1.1. Proof of accreditation shall be carried at all times on the competition area and shall be shown on request of appropriate officials.
- 3.8.1.2. Only holders of appropriate accreditation shall be allowed onto the relevant parts of the competition area.

Accreditation card:

- Athletes and team officials, registered in WAREOS, will be issued an accreditation and lanyard. Please ensure all details are correctly entered in WAREOS.
- Accreditation will be done by IANSEO and LOC using WA database during Saturday May 13 and Sunday May 14 morning. TMs will check at IANSEO designated tent accreditation cards for their team and will cooperate with IANSEO if there for example are data and/ or photo missing and/ or incorrect.

5.4 Wheelchair anti-rolling devices

For wheelchairs, the number of anti-rolling devices (wedges) are now limited.
 If the ground is uneven, a block to level the chair is allowed.
 A maximum of two anti-rolling devices (wedges) behind or in front of the rear wheel, may

be used only if there is significant slope at the shooting line shooting position surface. At flat shooting positions (artificial or ground) surfaces, anti-rolling devices (wedges) in contact with wheel(s) and the shooting position surface are not allowed. Chair mounted wheel brake devices that do not contact the shooting position surface are permitted. The use of anti-tipping devices is allowed provided they do not touch the ground.





5.5 Cell phone mounted on a scope is not legal

• Interpretation effective 15 April 2023 - the use of Tablets, Smart phones or any other electronic media devices for the purpose of enhancing spotting scope images are not legal.

6 Logistical aspects (OC)

6.1 Transportation

Based on the WAREOS registration LOC will arrange for local transportation for the teams flying to PRG international Airport and paying to LOC for such a service. Then there are either teams with their own local transport (private cars, rented minivans, buses) or teams ordering local transport from LOC.

Participants who fly to PRG International Airport will be met by either LOC driver/ volunteer at the arrival gate according to the flight itinerary and will be driven to hotel/ venue (arrivals until May 12); Participants arriving on May 13 will be met by LOC volunteers at Welcome Desk at Terminal 2 and either directly driven to hotel/ venue or will be asked to wait until next bus/ minivan is available for them. There will be refreshment at the Desk.

Teams that ordered LOC local transport refer to Mr. Matej SPRAVKA, LOC transport coordinator, on a daily basis to arrange for local transport (hotel – venue) according to a schedule.

6.2 Accommodation

Some of the teams are lodged in Spa Resort in Kudowa Zdroj in Poland. Crossing the border for the participants of the tournament is agreed by the both guards as it is considered an officially approved project within the European Union and Schengen territory and should be a smooth. However participants are recommended to have their passports, accreditation cards and the LOC Information Package (Permission to enter the Czech Republic for non EU countries) ready whenever they might be asked to prove so.

6.3 Meals during the event

There will be designated space for collecting and consuming of lunch boxes.

Cafeteria and buffet will be open during the tournament to purchase refreshment. Cafeteria and buffet accept only Czech currency (CZK); there are ATM or exchange office at the airport upon arrival and ATMs and exchange office in Komenskeho street in Nove Mesto (Komercni banka, CSOB, Ceska sporitelna).





6.3 Water:

Each participant will receive his/ her personal plastic bottle as a souvenir and will draft fresh water from designated pipes himself/ herself.

6.4 Non-Smoking

This is a non-smoking event.

Smoking is forbidden inside public buildings and all competition and training areas. This also includes electronic cigarettes, refer to book 3, Art.12.8.

6.5 The environment

Team managers, please instruct your team members to use the litter bins located at the competition, practice ranges and common areas at all times. Sanitary risky waste (masks, nife&fork, napkins etc.) should be thrown into blue plastic bags.

7 Impact of COVID-19

No sanitary measures related to COVID-19 pandemia apply anymore in the Czech Republic.


