5. Team Managers' Meeting

The event Technical Delegate, Mr. Randall Jones, will conduct a Team Managers' Meeting at the FOP (Dunbar Park). The meeting will be held on **Thursday**, **28 August**, **at 1:30 p.m.** (13:30), after lunch and before the PM session. Each team can be represented at the meeting by up to three (3) officials. The meeting will be conducted both in English and Spanish.

6. Competition Schedule

The times on the schedule are tentative: only the start time for each session (morning and afternoon) is fixed. It is possible that a stage of the competition may start a few minutes before the scheduled time. Therefore, we kindly request that you ensure your archers are present and ready for any matches that may start a few minutes earlier than planned.

7. Equipment Inspection

Equipment inspection will be officially conducted by the judges on **Thursday**, **28 August**. Please ensure that your athletes have their Classification Cards and any adaptive equipment, along with their bow, arrows, releases, and so on. Equipment Inspection will occur **at their shooting position** while archers are practicing. There will be no designated time by country nor will there be a designated area for Equipment Inspection.

The judges may conduct random checks of the archers' equipment during the competition which is allowed by the rules. Please advise your archers that they may be required to show their equipment to the judges at any time during the tournament upon their request.

8. Coaches' position on the field

As implemented at the 2022 Hyundai World Cup and other events, a space will be reserved for archers to place their equipment. The coaches and other team officials should not stand in this area, but behind a line on the field which will be located at least 7 meters away from the shooting line. During team matches, a specific position will be allocated to the coaches.

9. Targets and target faces

The target faces are produced by a World Archery licensed manufacturer, Maple Leaf Press.

12. Scoring

Scoring will be conducted using a paper scorecard and a PDA. The results manager and LOC staff will be available to explain to your archers and any agents how to enter the scores in the PDAs.

Please instruct your archers to verify that the scores entered in both the electronic and the paper scorecards are identical. All paper scorecards must have a total and show the number of 10's and X's. All scorecards must be completed with signatures. Please have the archer review their scorecard and sign it as the Archer, if possible. The absence of a total or a signature will cause the archer to be disqualified.

During finals, please instruct your archers' agents to verify that what is entered in the scorecard is exactly what is on the target. Archer's agents are expected to sign their archer's scorecard, to have a pen to mark arrow holes and to have a device to pull arrows from the target if needed.

13. Correction to U21 Target Faces

There was an error in the Invitation Package regarding the target faces that the U21 archers will be using:

U21 Recurve Open single full-size 40 cm target face at 18 m

U21 Compound Open 40cm (5-ring) triple face at 18 m

U21 W1 single full-size 40 cm target face at 18 m

14. Important Rules

- The shooting time for the individual categories in the 2025 Chicago Para-Archery Championship is 40 seconds per arrow (30 seconds in the individual finals).
- No extra time will be allowed to shoot arrows that were not shot within time due to equipment failures or medical issues.
- Changes in team composition for match play are allowed provided that the change is informed to the chairman of judges (or his deputy) or the results manager at least 15 minutes prior to the start of the first team round in the category concerned. The form to communicate these changes can be found at the end of this booklet. If a team does not submit a team composition form, it will mean that the archers shooting team matches will be the ones who qualified the team (the highest ranked ones). For the 2025 Chicago Para-Archery Championship, both the Doubles and the Mixed Teams events will be unofficial events. More information on these events will be forthcoming.

15. Team Uniforms

All World Archery rules in connection with uniforms will be applied, except for the World Cupspecific rule that requires archers and teams shooting finals to have two uniforms with different colors. The rule on sleeve colors for finals matches will be enforced.

16. Classification

The classification of para-archers will be conducted at the Marriott Marquis Chicago on **Wednesday, August 27**. The specific room for classification remains to be determined, and it will be communicated once known. World Archery has conferred upon those VI archers needing to be classified a **temporary classification** to participate in the event, and they will receive a card from the Chief Classifier to this effect.

The classification schedule has been distributed to all national federations with archers in their rosters who need classification. Please ensure that all of your impacted archers and team officials are aware of their classification date and time. The classification schedule can be found on IANSEO.

Please ensure that your archers arrive at least 10 minutes prior to their scheduled classification time. They will need to bring their passport or national identification, all of their adaptive Version 0.2





equipment and their bow(s). A Coach or Team Manager may accompany the athlete. Classification will be conducted in English, so an English-speaking member of your team should accompany the athlete if necessary. If no member of your team speaks English, you may require the presence of a bilingual LOC volunteer to assist with translation. The classification cards may be distributed following on-field observation, if required to complete the evaluation.

17. Practice

Practice facilities will be available starting August 26. There will be unofficial practice at Lincoln Park on Tuesday, August 26 and Wednesday, August 27, from 09:00-12:00 and from 13:00-16:00. Teams and athletes arriving early are responsible for their own transportation to and from the unofficial practice field in Lincoln Park.

Official practice will be held on Thursday, August 28, from 10:00-12:30 and 14:00-16:30.

Transportation will be provided from the event hotel to the FOP, and a schedule will be made available on IANSEO.

On Sunday, August 31, a portion of the field will be available for archers shooting the finals matches only, starting at 11:00.

18. Archers in the VI Category

A section of the field will be designated for the archers in the VI category. The targets will not be moved, and each archer will always shoot at the same target throughout the event. The position of the faces on the butts will be marked so that it remains unchanged when a face is replaced. The VI stands will be allowed to stay on the field for the entire tournament.

19. Venue Access

Archers out of competition or who are retired from an event may not proceed past the athletes' tenting. They may remain in the FOP while bearing their accreditation.

The judges will strictly enforce the World Archery rules regarding the number of officials a team is allowed to have at the same time on the FOP. During individual matches, a team will be allowed one official for each archer in competition, plus the team manager in the event an appeal needs to be filed.

Overall, we may proceed with more flexibility given that some team officials may act as spotters for the VI archers or assistants to others.

20. Awards Ceremonies

All award ceremonies will be conducted after each stage of the competition at a time and place as per in-venue announcements. The flags may be shown electronically on the Jumbotron.

21. Airport pick up and drop off

The LOC will pick up the teams at the airport as per their status with the LOC. Arriving parties will be able to communicate directly with the Transportation Manager via WhatsApp to convey their status and whereabouts. LOC staff will be in attire related to the event.

If some luggage does not arrive with the team, please follow the usual baggage reclaim procedures and inform the LOC.

If your flights to the Chicago area are delayed or cancelled, please inform Alan Sochacki and Brent Harmon.

A schedule of departures will be posted on IANSEO in due time. Please check with the LOC that the flight schedules they have are correct, and the times reported are those arriving in Chicago and departing Chicago.

22. Breakfast and Lunch Service

Breakfast and Lunch will be served at the FOP on Thursday, August 28, Friday, August 29, and Saturday, August 30, according to the schedule indicated on IANSEO. Breakfast will be served on Sunday, 31 August.

These meals are included for guests staying at the accommodation provided by LOC. The food vendor will **not** be able to allow purchases on-site.

23. Hydration

Water dispensers will be provided and located under the athletes' tents. Cups will be available, but we encourage everyone to bring a reusable water bottle. Bottled water will be available in coolers, as well.

24. Transportation

A transportation schedule will be published on IANSEO. Please be advised that the times listed on the schedule refer to the scheduled departure times of the transport. This means that we encourage your team members to be down at the lobby, ready to board at least 15 minutes

before the shuttles are scheduled to leave. The organizing committee will not provide additional transport to participants who are not on time to board or who wish to follow a different time table.

25. FOP Bow Storage

The organizing committee will make a storage area available at the venue for the archers to leave their equipment. This container will be located outside but adjacent to the field of play. Since private security has been employed to monitor this storage area, it is very secure to do so.

26. Appeals

The Jury of Appeals will operate with three members at a time. They will be chosen from the pool of four members appointed by the COJ. The choice will depend on which countries are directly involved in the appeal and on the presence of the potential members at the venue at the time the appeal is lodged.

According to World Archery Rules, an intention to appeal must be presented to the Chairman of Judges not later than 5 minutes after the end of a stage of the competition or before the start of the next stage, whichever happens first.

Team managers have up to 15 minutes (including the five minutes referred to in the previous paragraph) to lodge the appeal in the proper format. The Chairman of Judges shall reject either the intention or the actual appeal if the time limits are not complied with.

According to a recent by-law change, the Chairman of Judges has the right to correct a mistake made by a judge if there is enough evidence before an appeal is lodged with the Jury. These corrections do **not** include changing the value of an arrow called by the judge or overturning a yellow card decision in a team match.

27. Anti-doping Tests

Anti-doping tests will be conducted at the FOP by USADA.
