Equipment checks will be carried out by the Judges prior to Assembly. Archers are responsible for ensuring their equipment meet the required standards for competition. N.B. Junior Members shooting must be supervised by a Parent or Guardian at all times.

Local Archers please choose Detail 'A' if possible.

Practice - Group A: 10.30 a.m. Group B: 2.30 p.m.

N.B. Only shoes with non-marking soles are to be worn in the Sports Hall.

Archery GB cards to be shown on arrival.

Awards: GWAS Trophies for Lady & Gentleman Champions (Recurve, Compound, Barebow & Longbow); GWAS Team Trophy for a Club Team of four Archers (Recurve); GWAS Team Trophy for a Club team of four Juniors (Recurve).

Drug Testing: Record Status Shoots are liable for drug testing and Competitors approached to give samples, must comply; if they refuse, that refusal will be treated as a positive result.

N.B. When you enter competitions the following information may be collected and shared with Tournament Organisers, scoring systems and other competitors: target lists and results may be published with First Name, Surname, Gender, Bow-style, Date of Birth / Age category, Email, Address, Phone number, Club (and ID), County (and ID), Region (and ID), Round (unless defined by age) & Disability info.

Neither GWAS nor the owner of the venue will accept liability for loss, damage or injury whilst on the premises.

COVID 19: The event will be following Government & AGB guidelines at the time of the competition & changes at short notice may have to be made. Archers are reminded that if they or anyone close to them have COVID 19 symptoms or feel unwell on the day, then they should stay away from the competition. You are welcome to bring your own sanitiser, face coverings or PPE. You are encouraged, but not required, to have a negative LFT before the tournament. The presentation of awards will depend on the COVID restrictions at the time of the tournament; if necessary, medals will be sent by post.
