LAA Junior Outdoor Championships and Open Competition 2023 – Information Sheet

1. The Tournament is open to all archers aged under 21 on 31st December 2023 (Rule 308 (b) (i)). An archer may enter the round appropriate to his/her age group or that of an older group, but will only be eligible for a prize in the round shot.
2. The entry fee is £15.00. Please return entry form(s) with the appropriate fee to the Tournament Organiser at the address given. Please make cheques payable to “Lancashire Archery Association Tournaments”. Payment by bank transfer is available: Lancashire Archery Association Tournaments, sort code 30-99-50, account number 44791868 (please reference competitor name).
3. Entries will be processed in order of receipt. Please contact the Tournament Organiser if you require acknowledgement of your entry. Incomplete or unfunded applications will not be accepted.
4. No entries will be accepted after the closing date of 27th May 2023. No refunds after the closing date.
5. The provisional target list and results will be published on the LAA website.
6. Competitors must provide proof of current Archery GB membership on registration.
7. In line with the Archery GB Safeguarding Children and Young People Policy, anyone wishing to take photographs or video at the shoot must register with the Tournament Organiser prior to doing so.
8. As this is a Record Status tournament, competitors will be liable for drug testing. Those approached to give samples must comply; a refusal will be treated as a positive result.
9. Neither the Lancashire Archery Association nor the Tournament Organiser is able to accept responsibility for the care of children. Junior competitors or spectators (u18) must be accompanied by a responsible adult for the duration of the tournament.
10. Lancashire Archery Association will not be responsible for damage to equipment.
