Round: World Record Status World Archery 70/60/50 + Individual Head 2 Head

Longbow, Senior Recurve and U21 Recurve Archers will shoot 70m.

Under 18 and 50+ Recurve archers will shoot 60m. Compound and
Barebow archers except for U15 will shoot 50m. Compound and Recurve
archer shooting in the u15 category will shoot 40m. Barebow U15
Archers will shoot 30m

All Recurve, Longbow and Barebow archers will shoot a 122cm target face. Compound Archers will shoot an 80cm 6 ring target face. U15 Compound archers will shoot an 80cm full face.

Anyone who is shooting the correct age groups will be eligible for records and awards. Archers may choose to shoot 'down' a category; however, they will be non-eligible for medals and awards. The event will be ran under World Archery Rules and Regulations. Archers should be familiar with these procedures.

Assembly- 9; 45am

Official Practice – 9.55am

Shooting Ends

Shooting will be in ends of three arrows with 3 minutes to shoot the arrows. The event will be controlled using the CHRONOTIR Timing System.

The tournament will be controlled by the DoS (Director of Shooting) using the CHRONOTIR timing system.

The CHRONOTIR will use audio and visual signals to control the shooting. Archers need to be familiar with the below signals.

Red Light → Archers should not shoot

Amber Light →30 seconds or less remaining on the time

Green Light → Archers are free to shoot

2 Blasts → Archers have 10 seconds to come to the line, they can load their arrow into the bow but cannot raise their bow arm to shoot

1 Blast → Archers can begin shooting

3 Blasts → Archers are to collect their arrows

5 Blasts → Emergency Stop, archers should stop shooting immediately



Membership

Archers must hold a valid Archery GB membership. Alternatively, members of World Archery affiliated bodies are welcome to shoot provided suitable insurance is provided. Archers should have evidence of

their affiliation to AGB/ WA Body on the day of the competition, random inspections may be completed.

Entry

All entries must be submitted through the form. The Tournament Organiser has the right to refuse anyone entry to the competition. Entries will close Wednesday 16^{th} July . Entry to the competition will cost £12 for senior entries and £10 for junior entries. Should a Junior wish to shoot in the senior competition instead they are must pay the senior entry fee

Results

Results for the competition, including target allocations will be posted to ianseo. Results from the competition will be unofficial until the arrow-by-arrow verification of scorecards take place, once complete results will be official. Scorecards which are not signed for by the archer and the scorer will be disqualified. The failure to complete the 10 +X and Xs columns will result in a 0 score being awarded. Changing arrow values without a Judge correction will result in the loss of the arrow value.

Code of Conducts

Archery GB strive to have a welcoming and friendly atmosphere at all levels of competition, and for everyone attending to leave having enjoyed their day's competition. The TO and CoJ has the right to remove anyone from the field of play.

Archery GB welcome encouragement and cheering in support of competing athletes, in a good sporting manner.

- We are asking all individuals to please think how you are behaving at events when supporting people.
- Ask yourself what an acceptable way is to behave in a sporting environment.
- Please treat others as you would like to be treated yourself.
- When supporting people in matches please do so in good taste.
 - Please demonstrate good sportsmanship when supporting all athletes.
- o Examples of poor sportsmanship; the purposeful wrong calling of arrows or shouting loudly when an opponent is at full draw.

 If you feel anyone is behaving in an inappropriate manner at any competition you are attending, inform either the Head Judge or the Tournament Organiser, (both should make themselves known at assembly) The CoJ and TO has the right to ask any person to leave the competition

Scorecards:

Qualification Round

Scoring will be via paper. The paper scorecard arrow values must be identical. Should this not be the case the results team will take the lowest arrow value and record that score. The scorer must sign the paper scorecard and the archer to verify the score shot. Once a scorecard has been submitted, it cannot be returned. Handing a scorecard in is the archer and scorer signifying they are happy with the contents. The 10 + X and X column should be completed failure to complete will result in a zero score. If there is a discrepancy between the papers 10 + X and X count, the lowest score will be taken. Arrow values that have been changed without a Judge correction will be deemed a Miss.




Individual Matches

Scoring will be completed by paper only,. Archers shall swap scoreboards and score each others arrows. Archers will score each others arrows and record them on the board. Recurve, Barebow and Longbow Archers will use set points to determine winners. When an archer has obtained 6 set points they will be declared the winner. Compound Archers will shoot 5 ends and take the highest score after this is complete. Archers and opponents must sign both scorecards to verify the score and declare they are satisfied with the match result. Scorecards must have the archer and opponent score correctly completed and mathematically correct, failure to do so will result in disqualification.
